1 製品概要

1.1 Systemwalker Desktop Patrolとは

Systemwalkerとは、富士通株式会社が提供する分散システムの運用管理製品の総称です。

Systemwalker Desktop Patrolは、監視対象のPCのハードウェアおよびソフトウェアに関する資産情報を管理し、セキュリティ状況の確認や、必要に応じてセキュリティパッチを自動的に適用したり、廃棄するPCのハードディスク情報を消去して、情報漏洩を防ぎます。これにより、企業外部から内部へのセキュリティ上の脅威に対し、ICT資産を守ります。

また、内部統制で求められるICT資産の保全において必要なICT資産情報の台帳を作成したり、ICT機器情報の自動検知によって、システムの正しい運用の実現とその証明・監査を実現します。

さらに、グリーンICTへの対応として、PCの設定の改善を促すアラームや自動設定により、管理者に負担をかけずに省電力を実現する機能を提供します。

(1) プログラム本体

次のプログラムからなります。

- ・ Systemwalker Desktop Patrol CS (Corporate Server)
 - インベントリ情報の収集条件やソフトウェア配信の運用条件をポリシーとして定義し、各PCに配信するサービスを受け持つサーバです。
 - ICT資産の情報(ICTリポジトリ)、人、組織などの組織情報を格納したデータベースにより、セキュリティパッチの配信、セキュリティの監査やライセンスの管理をWebブラウザから行うサービス (Web GUI) を提供します。
 - 通常は企業に1台導入されます。
- ・ Systemwalker Desktop Patrol DS (Domain Server)
 - 運用ポリシー、インベントリ情報、配信ソフトウェアなどの集配信の中継/格納をサービスするサーバです。
 - 負荷分散するためなどの目的のために設置します。クライアントが遠隔地にあり、低速回線の場合、または配信するソフトウェアの容量が大きい場合などに有効です。
- ・ Systemwalker Desktop Patrol AC (Asset Console)
 - 資産、セキュリティ、省電力などの各種レポートの出力やバーコードの出力などを行う管理者用コンソールです。
- ・ Systemwalker Desktop Patrol ADT (Auto Detection Terminal)
 - セグメント毎に設置し、同一セグメント内のネットワークに接続されている機器を自動検知します。また、検知した機器の情報を、管理サーバ(CS)に通知します。
- ・ Systemwalker Desktop Patrol CT (Client Terminal)
 - 管理されるクライアントです。インベントリ収集により資産を管理するPCに導入します。「Systemwalker Desktop Patrol CT」で、配信ソフトウェアのダウンロード、セキュリティパッチの受信を行います。
 - また、管理者の設定により、省電力ポリシーの違反、セキュリティポリシーの違反があると、対処を促す画面が表示されます。
- ・ Web GUI
 - 「Systemwalker Desktop Patrol CS」が提供するサービスを利用し、WebブラウザからSystemwalker Desktop Patrolの運用操作を行うための操作ビューです。
 - また、「Systemwalker Desktop Patrol」の動作ポリシーを設定できます。
 - Web GUIには、「メインメニュー」および「ダウンロードメニュー」があります。
- ・ Systemwalker Desktop Patrol SS (Secure Server [ゲートウェイサーバ])
 - セキュア版CTの接続を受け付けるための中継サーバです。

- ・ Systemwalker Live Help Expert
「Live Help Client」をリモート操作するためのソフトウェアです。クライアントユーザーが、PCの操作に困っている場合などで、直接クライアントユーザーのPCに接続して、支援できます。
- ・ Systemwalker Live Help Client
「Live Help Expert」からリモート操作されるソフトウェアです。支援を必要とするクライアントユーザーのPCや、リモート操作で運用するサーバに導入します。クライアント側は、「画面上のメッセージに対して、どう応えたらいいのかわからない」や、「アプリケーションの操作方法がわからない」などの場合に、「Live Help Expert」からの遠隔操作によって、支援を受けることができます。

Systemwalker Desktop Patrol CS → “Desktop Patrol CS”、または“CS”に略します。

8.1 Desktop Patrol CS/DS/CTに関する注意事項

8.1.1 Desktop Patrol CS/DS/CTに関する注意事項

Systemwalker Desktop PatrolをインストールしたフォルダをOS標準機能で暗号化を行うとIT BudgetMGR(INV)サービスは動作しません。

8.1.2 Desktop Patrol CSに関する注意事項

(1) 下位サーバが上位サーバとの通信にプロキシサーバを利用している場合、プロキシサーバの種類によって下記に示す注意事項があります。

- Microsoft Proxy Server
 - ・バージョン2.0.389(BackOffice1に入っているもの)以降を使用してください。それ以前のバージョンを使用した場合には転送に失敗することがあります。
 - ・SSLでの暗号化通信は行えません。

8.1.3 Desktop Patrol CTのCT情報変更ツールに関する注意事項

CT情報変更ツールは、Desktop Patrol CTに設定されたユーザーID、PC名、接続サーバ、ユーザー情報を変更するためのツールです。

CSのホスト名変更時にCTの接続先サーバ名が変更となる場合は、本ツールを使用して

複数台のCTの接続先サーバ名を変更できます。CSのホスト名変更前に本ツールを使用し、新しいホスト名をCTに設定してください。

8.2 エラー発生時の注意事項

(2) ログ採取ツールについて

エラー原因を調査するため、エラーログやトレースログの採取が必要な場合があります。ログ採取ツールによる情報の採取方法については、「Systemwalker Desktop Patrol リファレンスマニュアル」の“第5章 調査用の情報を採取する”を参照してください。

8.3 ソフトウェア辞書に関する注意事項

8.3.1 自動パッチ適用の運用環境について

セキュリティパッチの自動適用において、再起動が必要な場合があります。

「電源が入っている場合に定期的に適用する」や「ログオンしている場合に定期的に適用する」の設定を行った場合、電源投入時およびシステム再起動時に、起動処理が停止しないように留意していただく必要があります。

(1) 電源投入時・システム再起動時

- ・パソコン本体のBIOSパスワード設定が行われている場合、パスワード入力待ちになります。
- ・CD-ROMやDVD-媒体が装着されたままになっていると、システムの起動に失敗することがあります。パソコン本体のBIOS設定画面で、ハードディスクから起動する設定にしていただくよう推奨します。

(2) 省電力モードの設定について

「電源が入っている場合に定期的に適用する」や「ログオンしている場合に定期的に適用する」の設定を行った場合、省電力モードの設定の中で、システムを停止するような設定の場合に自動適用できないことがあります。

8.3.2 サーバシステムにおける自動パッチ適用

セキュリティパッチをサーバに自動適用し、再起動が必要になった場合には、業務のサービスが停止するおそれがあります。

自動適用のスケジュールや適用方法については、事前に評価・検証を行っていただいたうえで、問題回避をしていただくようお願いいたします。

8.3.3 自動適用できないパッチについて

マイクロソフト株式会社から公開されているセキュリティパッチの中で、自動適用できないものがあります。自動適用できないパターンは以下の通りです。

- パッチ適用の際、または、パッチ適用後のシステム再起動時に、同意を求めるキー入力操作や、処理完了後の確認キー操作が必要なパッチ
- Desktop Patrol CSIにダウンロードできないWindows Updateでのみ提供されるパッチ

※ 上記パッチには、Windows Updateカタログからお客様自身でパッチダウンロード後にメインメニューでパッチの登録操作を行うことで自動適用できるものがあります。

- マイクロソフト株式会社とサポートサービス契約した場合にのみ入手可能なパッチ
- パッチ適用中にインターネットに直接接続するパッチ
- パッチ適用の際に、CD-ROMを要求するパッチ (例:Office製品のサービスパック、および、セキュリティパッチ)
 - ※ CD-ROMを要求された場合、媒体を準備し応答することで、手動適用を行ってください。
- パッチ適用時にサーバ機能を停止する必要があるパッチ (例 : SQL serverのパッチ)

上記のパターンに該当するパッチは、セキュリティ監査の機能で未適用の検出はできませんが、自動パッチ適用対象外となります。

SAMACのソフトウェア辞書を移入するためには、お客様にて辞書の購入が必要です。

8.4 Live Help Clientの配信について

8.4.1 自動配信指定

Live Help Clientを自動配信する場合は、Desktop Patrol CS/DSをインストールした後で、Web GUIよりLive Help Clientインストールファイルを配信コンテンツとして登録してください。

登録する場合にはインストールファイルの格納されているフォルダ配下をzip形式で圧縮し、「圧縮した複数ファイル/フォルダ」としてアップロードしてください。アップロード後必ず「ファイルを実行する」の配信後実行ファイルにLive Help Client インストールファイル名 (Setup.bat) を指定し、「CTでのダウンロード方法」で自動をチェックしてください。

「LiveHelp_Client_Install」フォルダを含めないよう注意してください。

8.4.2 Live Help Clientインストールフォルダ

8.5 Live Helpに関する注意事項

一台のコンピュータで、複数の Live Help 製品を動作させることはできません。

Systemwalker Live Help は、単体製品として販売していますが、Systemwalker Desktop Patrol に添付している他、Systemwalker Centric Managerにも組込んでいます。

このため、本製品のリモート操作(Live Help)を既に導入している環境に、Systemwalker Centric Manager の Live Help を導入する場合は、先に本製品のリモート操作(Live Help)をアンインストールする必要があります。

また、本製品のリモート操作(Live Help)を既に導入している環境に、単体製品の Live Help を導入する場合は、単体製品の Live Help のインストールの際に、本製品のリモート操作(Live Help)のインストール先フォルダを指定して、上書きインストールしてください。

8.5.2 Live Help のインストール先に関する注意事項

手動またはカスタマイズウィザード機能を使用して、Live Helpのインストール先の指定を行う場合、Systemwalker Desktop Patrol GSがインストールされているフォルダおよびその配下を指定しないでください。

8.5.3 Live Help のアンインストールに関する注意事項

Live Help のアンインストールは、必ず以下の手順で行ってください。

- (1) Live Help Expert、またはLive Help Clientが起動している場合は、終了させてください。
- (2) [コントロールパネル]-[アプリケーションの追加と削除]または、[プログラムと機能]から、以下を選択して削除してください。

「Live Help Expert」を選択して削除してください。

[Clientの場合]

「Systemwalker Desktop Patrol Live Help Client」もしくは、「Live Help Client」を選択して削除してください。

Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

For example, if you distribute copies of the library, whether gratis or for a fee, you must give the recipients all the rights that we gave you. You must make sure that they, too, receive or can get the source code. If you link other code with the library, you must provide complete object files to the recipients, so that they can relink them with the library after making changes to the library and recompiling it. And you must show them these terms so they know their rights.

We protect your rights with a two-step method: (1) we copyright the library, and (2) we offer you this license, which gives you legal permission to copy, distribute and/or modify the library.

To protect each distributor, we want to make it very clear that there is no warranty for the free library. Also, if the library is modified by someone else and passed on, the recipients should know that what they have is not the original version, so that the original author's reputation will not be affected by problems that might be introduced by others.

Finally, software patents pose a constant threat to the existence of any free program. We wish to make sure that a company cannot effectively restrict the users of a free program by obtaining a restrictive license from a patent holder. Therefore, we insist that any patent license obtained for a version of the library must be consistent with the full freedom of use specified in this license.

Most GNU software, including some libraries, is covered by the ordinary GNU General Public License. This license, the GNU Lesser General Public License, applies to certain designated libraries, and is quite different from the ordinary General Public License. We use this license for certain libraries in order to permit linking those libraries into non-free programs.

When a program is linked with a library, whether statically or using a shared library, the combination of the two is legally speaking a combined work, a derivative of the original library. The ordinary General Public License therefore permits such linking only if the entire combination fits its criteria of freedom. The Lesser General Public License permits more lax criteria for linking other code with the library.

We call this license the "Lesser" General Public License because it does Less to protect the user's freedom than the ordinary General Public License. 0. A "library" means a collection of software functions and/or data prepared so as to be conveniently linked with application programs (which use some of those functions and data) to form executables.

If the distribution and/or use of the Library is restricted in certain countries either by patents or by copyrighted interfaces, the original copyright holder who places the Library under this License may add an explicit geographical distribution limitation excluding those countries, so that distribution is permitted only in or among countries not thus excluded. In such case, this License incorporates the limitation as if written in the body of this License.

13. The Free Software Foundation may publish revised and/or new versions of the Lesser General Public License from time to time. Such new versions will be similar in spirit to the present version, but may differ in detail to address new problems or concerns.

Each version is given a distinguishing version number. If the Library specifies a version number of this License which applies to it and "any later version", you have the option of following the terms and conditions either of that version or of any later version published by the Free Software Foundation.
