5.1 IPv6環境での運用について

- ・Agent/Proxy ManagerとManager間、およびインストールレス型AgentとManager/Proxy Manager間の通信が、以下の場合について管理対象のIPv6環境をサポートします。
 - Agent/Proxy Manager - Manager間 (Push通信)
 - インストールレス型Agent - Manager/Proxy Manager間 (TELNET/SSH/HTTPS/WMI通信)

- ・ IPv6環境のAgent/Proxy Manager/インストールレス型Agentを管理する場合、ManagerはIPv4/IPv6デュアルスタック環境にしてください。また、Manager - 運用管理クライアント間はIPv4で通信できるようにしてください。
- ・ IPv6のみの環境の場合、Windows版 Managerと運用管理クライアントを同居させる構成にすることにより動作可能です。

5.2 Windows Server 2019およびWindows Server 2016上で管理コンソールおよびコンソールを使用する場合の制限

Windows Server 2019およびWindows Server 2016上で管理コンソールおよびコンソールを使用する場合、Microsoftのソフトウェア更新の影響を受け、Microsoft Edge (IEモード)が正常に動作しない場合があります。
Windows Server 2019およびWindows Server 2016上で管理コンソールおよびコンソールを使用する場合は、Internet Explorer 11を使用してください。

5.3 Internet Explorer 11で管理コンソールおよびコンソールを使用する場合の制限

以下の条件で管理コンソールまたはコンソールを使用する場合、Internet Explorer 11の不具合により、空白のウィンドウが表示されたり、ボタンが機能しなかったりするなど、正常に動作しません。

7.2 運用管理クライアントをインストールするマシンと、ブラウザを使用してコンソールの表示を行うマシンの、タイムゾーンと言語について

運用管理クライアントをインストールするマシンと、ブラウザを使用してコンソール

の表示を行うマシンの、タイムゾーンおよび言語は、同じにしてください。
同じにしないで使用した場合、画面が文字化けするなどの問題が発生することがあります。

7.3 コンテンツ表示エラーについて

コンソールのサマリ表示・詳細表示、および分析・レポート画面において、表示ボタンや作成ボタンにより目的のコンテンツ（グラフや表）を表示しようとする時、以下のような現象が発生する場合があります。

- ・グラフの画像の代わりに、エラーコード：1572864 が表示される。
- ・グラフの画像の代わりに“Chart is unavailable”と表示される。
- ・グラフの画像が抜け落ちる（グラフのみ表示されない）。
- ・次のエラーメッセージが表示される。
 - “The specified CGI application misbehaved by not returning a complete set of HTTP headers. The headers it did return are: Unable to register TclNotifier window class”
 - “ohd_update error.”
 - “Ohd file create error.”

また、レポート作成コマンド(sqcMakeReport.exe)を実行した時に、以下のコードで例外が発生する場合があります。

- ・ 0xe06d7363
- ・ 0xc0000005

これらの現象は、原因として運用管理クライアントのデスクトップヒープ(Desktop heap)が不足していることが考えられますので、以下の方法でデスクトップヒープを拡張してください。

- (1) レジストリエディタを起動します。
- (2) HKEY_LOCAL_MACHINEのサブツリーから以下のキーを表示します。
¥System¥CurrentControlSet¥Control¥Session Manager¥SubSystems
- (3) Windowsの値の中、SharedSectionパラメーター（下記例の下線部分）のカンマで区切られた3番目の数値を、256KBずつ20480までの範囲で拡張します。
カンマで区切られた数値は、システムにより3つの場合と4つの場合があります。
どちらの場合も3番目の数値を拡張してください。

(4) システムを再起動します。

レジストリの編集を誤ると、Windows が起動しなくなるなどの影響が発生する場合があります。レジストリの編集には注意してください。

7.4 tclsh84.exeのアプリケーションエラーについて

運用管理クライアントやWindows版のEnterprise Manager/Manager/Proxy Manager/Agentで、以下のようなtclsh84.exeのアプリケーションエラーが発生する場合があります。

この現象は、原因としてManagerやAgent、運用管理クライアントのデスクトップヒープが不足していることが考えられます。この場合、「7.3 コンテンツ表示エラーについて」で説明する方法で、デスクトップヒープを拡張してください。

7.5 サーバ性能情報の未取得について

コンソール画面の各種表示機能において、サーバ性能情報が表示されなくなる（性能情報が未取得となる）ことがあります。この現象は、Windowsの問題 (KB248993) で、Microsoft社から回避する方法が広報されています。詳細については、Microsoft社のページなどを参照してください。

7.6 Systemwalker Centric Managerのレポート機能が混在した環境におけるSystemwalker Service Quality Coordinator のアンインストールについて

Systemwalker Centric Managerのレポート機能と、Systemwalker Service Quality Coordinatorの運用管理クライアントが混在しているコンピュータでは、運用管理クライアントとSystemwalker Centric Manager レポート機能でグラフ表示に必要なライブラリの設定を共有して使用します。そのため、運用管理クライアントをアンインストールした場合、Systemwalker Centric Manager レポート機能が使用しているライブラリがシステムから登録解除され、レポートの作成に失敗します。この場合、レポートを表示するためには、Systemwalker Centric Manager レポート機能に付属したコマンド“regfxdll.bat”を実行し、ライブラリをシステムに登録してください。

上記の現象はSystemwalker Centric Manager V13.0からV15.2のレポート機能で発生する可能性があります。

コマンド“regfxdll.bat”については、以下の手順で実行してください。

- (1) コマンドプロンプトを開き、カレントディレクトリを以下のディレクトリに変更します。

7.7 Internet Explorerに関する留意事項

- (1) 管理コンソールのボタンの動作不可について

[留意事項内容]

Systemwalker Service Quality Coordinatorの管理コンソールのボタンを操作すると、Internet Explorerの情報バーに、「この Web サイトはスクリプト化されたウィンドウを使用して情報を依頼しています。この Web サイトを信頼している場合、ここをクリックして、スクリプト化された ウィンドウを許可してください...」とのメッセージが表示され、ボタンが動作しないことがあります。

[原因]

Java Scriptによる分離したプロンプトウィンドウが表示されることをブロックするため発生します。

[対処方法]

Internet Explorer情報バーをクリックし、[スクリプト化されたウィンドウの実行を一時的に許可]を選択してください。

- (2) ステータスバーにSystemwalker Service Quality Coordinatorが出力する各種メッセージが表示されない件について

[留意事項内容]

管理コンソールの表示中、Internet ExplorerのステータスバーにSystemwalker Service Quality Coordinatorが出力する各種メッセージが表示されないことがあります。

[原因]

スクリプトでのステータスバーの更新を許可するかどうかのセキュリティ項目が追加され、デフォルトでは、以下の設定になっています。

- 「インターネット」ゾーンでは許可しない。
- 「ローカル イン트라ネット」ゾーンでは許可する。

また、イントラネットのネットワークの自動検出が正しく動作せず、インター

ネットゾーンのセキュリティレベルで管理コンソールが動作してしまうことがあります。
これらの理由により、ステータスバーにメッセージが表示されません。

[対処方法]

1. Internet Explorerの[ツール]ボタンをクリックし、表示されたプルダウンメニューから[インターネット オプション]を選択します。
2. 表示された[インターネット オプション]画面の[セキュリティ]タブを選択し、[ローカル イン트라ネット]ゾーンを選択します。
3. [サイト]ボタンをクリックし、表示された[ローカル イン트라ネット]ダイアログの、[イントラネットのネットワークを自動的に検出する]チェックボックスを外し、その他のチェックボックスを全てチェックした状態で、[OK]ボタンをクリックし適用してください。

(3) レポートの「コピー」を行おうとすると、ダイアログが表示される件について

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.
