Systemwalker Centric Managerは、情報システムの運用管理を行うための統合基盤となる製品で、システムを構成するIT資源(ネットワーク、ハードウェア、OS、アプリケーション、利用者など)および業務のライフサイクル・マネージメントに従って、運用管理機能を提供するソフトウェア製品です。

さらに、EE版は大規模、高信頼な環境向けの製品で、SE版の機能に加えて、マネージャの階層化やクラスタ対応など柔軟な運用形態、高信頼システムを管理するための機能などを提供します。

### ■ Open 監視機能とは

Systemwalker Centric ManagerのOpen監視機能は、業務システムの個別監視を行うための機能です。

Systemwalker Centric ManagerのOpen監視機能を使用することにより、業務システムの個別監視と共通のインフラ監視を、システム利用部門とデータセンター管理部門で分担して行うことができます。

(b) under Patent Claims infringed by the making, using or selling of Original Software, to make, have made, use, practice, sell, and offer for sale, and/or otherwise dispose of the Original Software (or portions thereof).

(c) The licenses granted in Sections 2.1(a) and (b) are effective on the date Initial Developer first distributes or otherwise makes the Original Software available to a third party under the terms of this License.

### Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public License is intended to guarantee your freedom to share and change free software—to make sure the software is free for all its users. This General Public License applies to most of the Free Software Foundation's software and to any other program whose authors commit to using it. (Some other Free Software Foundation software is covered by the GNU Library General Public License instead.) You can apply it to your programs, too.

When we speak of free software, we are referring to freedom, not price. The licenses for most software are designed to take away your

This license, the Lesser General Public License, applies to some  
specially designated software packages--typically libraries--of the  
Free Software Foundation and other authors who decide to use it. You  
can use it too, but we suggest you first think carefully about whether  
this license or the ordinary General Public License is the better  
strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use,  
not price. Our General Public Licenses are designed to make sure that  
you have the freedom to distribute copies of free software (and charge  
for this service if you wish); that you receive source code or can get

b) Use a suitable shared library mechanism for linking with the Library.
